Subject: Mr. Ramin (Alireza) Peramon defamation's of IOPHR members

Dear Mr. Ramin (Alireza) Peramon, the respected director of the social media program named "Shir and Khurshid News", in one of the programs prepared and broadcast on your YouTube channel on October 13, 2022 (program no. 692), a person under a nickname N. and surname S. introduces himself to you. Then in the subsequent conversation with you, makes completely false and misleading claims in regards to respectable members of the International organisation to preserve human rights (IOPHR).

In your YouTube program, you in effect gave permission and the opportunity for your guest to make slanderous comments and to make defamatory slanders without asking him to provide any form of documents to prove his false claims and slanders.

Dear Mr. Ramin Peramon, you should know that the above-mentioned Mr (A.S.) does not act as a single individual, but he is a member of a known network of people, who have consistently for a long time, been committing destructive activities against the IOPHR.

The record of your program's guest actions, including audio-video files and written documents with the signature and photos of his false identity as Mr (A.S.) during the past few years, reveal the faces of each and every member of the network to which the aforementioned person is affiliated with. The members of this network are scattered in different parts of the world from Toronto, Canada to various European cities and Tehran and other cities in Iran. At the same time, they all operate and act regularly as part of an organized network and in an interconnected manner.

Of course, the destructive operations of this network against human rights activists and social media activists who are members of the IOPHR are aimed at damaging the social credibility of IOPHR members, are not only limited to sites, pages and channels operating under real names. But this network also operates with the use of collection of Cyber facilities under fake names, as part of a network that uses its destructive operations for demonization and blackmail.

Dear Mr. Ramin Peramon through your You Tube program you have effectively become one of the people who have helped to spread the lies and slanders of Mr (A. S)! As you have publicly cooperated with him and committed the clear crime of "spreading lies and slander" against real and innocent people.

In fact, in your program dated October 13, 2022, you gave your slanderous and lying guest the opportunity to commit the clear crime of "defamation" with the aim of harming the dignity and reputation of the members of the IOPHR and the IOPHR organisation as a whole.

You should be aware that the act committed by Mr (A. S) is considered a very serious crime in the eyes of the law. But you should also be aware that your crime is more serious than the crime committed by Mr (A.S). As through your program you in effect disseminated the slanders against the IOPHR and its members through your audio-visual channel on the YouTube platform.

Dear Mr. Ramin Peramon, you should know that the damages caused by "media defamation" to real people and legal organisations by your "audio-visual media" can be presumed, and do not necessarily need to be proven, and thus the court can issue heavy final judgments against you and your colleagues, and your guest in your program.

Dear Mr. Ramin Peramon, we would like to remind you again that the act of the guest in your program is a clear example of the crime of defamation, which is considered a criminal offense, and your action is a clear example of participation in this crime. As your conversation with the person in question has been published and broadcast from your social media channel on the YouTube platform in audio-visual form on various social networks in the cyberspace.

Consequently, your action and the broadcast of your program is an example of the criminal offense of "spreading falsehoods with the intention of damaging the reputation of real persons and legal entities" and the media crime of "defamation" with the aim of "demonizing and slandering".

Propagating the slanders and lies of the abovementioned person (Mr A.S.) about the members of the IOPHR and this non-profit organization and disseminating it in the cyberspace, which can potentially be seen and heard by numerous users on social networks, is committing a crime.

Therefore, the filing of criminal and legal complaints against you and the aforementioned person and his associated network is being registered in the relevant courts and with the relevant international authorities for legal prosecution by the lawyers of the IOPHR against you, and the guest of your program Mr (A.S.) and his the network of supporters and his accomplices! Which no doubt will lead to legal prosecution, "relevant subpoenas" after going through legal procedures against Mr (A.S) who is reported to reside and operate in Copenhagen - Denmark.

In conclusion, we would like to inform you, as the real persons and the IOPHR as an organisation, who are the plaintiffs of this serious case in the international and European judicial forums, had no dealings with you before the preparation and public release of your audio-visual program (on October 13, 2022), this in itself can be viewed as an attack by your and your program against IOPHR and its members. For this reason, it is necessary for you to take the necessary measures as soon as possible to explain your positions to the IOPHR and each of its respected members - who have been insulted and slandered in your program.

Also, in your response you need to specify, if your slanderous guest, Mr (A.S) misused the opportunity that your program gave him, and it was contrary to your wishes, and if the expressed slanders were not approved by you. Or if the slanders and lies of this person were indeed accepted and approved by you? And was the content of your program part of a prior agreement between you and Mr (A. S). And thus your program was designed and implemented of this agreement?

You should also note that, your silence regarding this letter will be seen as a definite proof of your complicity and cooperation with Mr (A.S) and his malicious network, and will be brought to the attention of the judges of the case.
